

Dogezer Privacy Policy

Dated: 01.07.2018

This Privacy Policy (hereinafter – Policy) is designed to assist a User with understanding how Dogezer collects, uses, stores and discloses the information the User provides to the Dogezer.

The Policy applies to any and all information about User of Services (the User) that the Dogezer or its affiliates, including all persons belonging to the same group with Dogezer, may obtain in the course of the use of any of Dogezer’s official websites, social networks, programs, products or services, the Dogezer platform (above and hereinafter – Services) and during the performance of any agreements and contracts with the User.

By using the Dogezer Services the User expresses his/her/it unconditional agreement with this Policy and the conditions of processing the User’s personal information contained herein. If the User does not agree with these conditions, the User should not use the Services.

User cannot be under 16 years old.

Changes to Dogezer Privacy Policy

Dogezer may change this Policy in its sole discretion at any time. Any revisions to this Policy will be posted on the Dogezer official website www.dogezer.com (above and hereinafter – the Website). It is User obligation to periodically, at least every thirty (30) days visit the Website to review any changes that may be made to this Policy. User continued use of the Website constitutes User agreement to be bound by any such changes to this Policy. If User does not agree with this Policy, User is not authorized to use the Services.

The information, which Dogezer Collect

When User visits the Website or use the Service, the User may provide the Dogezer with two types of information: personal information the User voluntarily disclose that is collected on an individual basis; and information collected automatically when the User uses the Website or the Services (collectively, the “Information”).

Dogezer will collect Information from Users only if they voluntarily submit such information to Dogezer or gave permission to collect the Information. Users can always refuse to supply personally identification information; however that it may prevent them from engaging in certain Service related activities.

The Personal Information

Personal information is collected only when voluntarily offered and solely for purposes that are clearly identified on the Website. Personal information means any information relating to an identified or identifiable natural person, such as the User:

- Name
- Username
- Password
- E-mail address
- Cryptocurrency address
- Location data
- Mailing address
- Other personal information

Dogezer is not processing of personal data revealing racial or ethnic origin, political opinions, religious or philosophical beliefs, or trade union membership, and the processing of genetic data, biometric data for the purpose of uniquely identifying a natural person, data concerning health or data concerning a natural person's sex life or sexual orientation.

By providing Dogezer with User's personal information, the User also consents for the Dogezer to collect, hold, use and disclose the User's personal information in accordance with this Policy. In addition to providing the foregoing information, if the User chooses to correspond further with the Dogezer through e-mail or through the "contact" section of the Website or official social networks of the Dogezer, the Dogezer may retain, use and disclose the content of the User messages together with e-mail address and responses.

If the Dogezer is not able to relate a direct link to the User personally, this information is not personal data.

The Information which is Collected Automatically

When the User uses the Website or Services, the Dogezer automatically collects information from User devices. The Dogezer collects the following information:

Server Log Information: the Dogezer collects server log information when the User uses the Website, which may include (but is not limited to) the User login details, the date and time of visits, the pages viewed, IP address, time spent at the Website and the websites visited just before and just after the Website.

Device Information: the Dogezer collects information about the computer or mobile device the User uses to access the Website, including the hardware model, operating system and version, the web browser which used, and other device identifiers.

Telemetry Information. If the User employ any of the Dogezer open source software, the Dogezer may collect bandwidth upload and download speeds, the amount of free and used storage space on the User device and other statistics about devices.

Usage Information. If the User uses the Website, the Dogezer will collect metadata about the files the User upload for storage and the Dogezer will record instances in which the User have used the private key to authenticate communications.

Information Collected by Cookies and Other Tracking Technologies: The Dogezer and the Dogezer's service providers use various technologies to collect information when the User interacts with the Website, including cookies and web beacons. Cookies are small data files that are stored on the User devices when they visit a website, which enable the Dogezer to collect information about the device identifiers, IP address, web browsers used to access the Website, pages or features viewed, time spent on pages, mobile app performance and links clicked. Web beacons are graphic images that are placed on a website or in an email that is used to monitor the behavior of the user visiting the website or sending the email. They are often used in combination with cookies.

Usage and storage of Information

The Dogezer will only use and store the Information for purposes of:

- providing, maintaining, or delivering the Services;
- analyzing and tracking data to determine the usefulness or popularity of certain content and to better understand the online activity of the Users on Website;
- fulfilling the applicable legal or regulatory requirements;
- providing the User with the information or products or services that have requested;
- answering the User inquiry or responding to a communication;
- improving existing Service;
- developing new products or services;
- sending the User technical notices, support or administrative notifications;
- communicating with the User about news, products, services, events and other information the Dogezer think will be of interest to the User;
- monitoring and analyzing trends, usage and activities in connection with the Website;
- detecting, investigating and preventing fraudulent transactions or unauthorized or illegal activities;
- protecting the rights and property of the Dogezer's Parties (as defined below) and others;
- linking, connecting or combining Information the Dogezer collect from or about the User with other Information; and
- carrying out any other purpose or reason for which the Information was collected.

The personal data will be erased in case the data are no longer necessary in relation to the purposes for which they were collected. Dogezer will process personal data for the duration of your subscription/ usage of service and will remove the personal data from our records after cancellation.

The information stored on distributed ledger should be managed by User or Dogezer on behalf of the User. The data stored by User or Dogezer on behalf of the User on a distributed ledger cannot be deleted by Dogezer due to technological restrictions.

In case the User wants the Dogezer to delete the User personal data or revoke consent granted to Dogezer for certain processing of the User personal data, User shall contact the Dogezer. The User can delete he/she/its account information by confirming this setting in own profile.

User may update the User's personal information by submitting requests in writing to community@dogezer.com

Users' rights:

Users have the following rights:

- ask Dogezer to confirm whether Dogezer is processing the User's personal information;
- receive information on how the User's data is processed;
- obtain a copy of the User's personal information;
- request that Dogezer updates or corrects the User's personal information;
- request that Dogezer deletes personal information in certain circumstances;
- request that Dogezer ceases processing of the User's personal information:
 - for marketing activities, including profiling;
 - for statistical purposes;
 - with third specific party;
 - where such processing is based on Dogezer legitimate business interests;
 - for processing the User's personal information for the establishment, exercise or defense of a legal claim;
- request that Dogezer limits the processing of the User personal information:
 - while Dogezer is evaluating or in the process of responding to a request by User to update or correct the User's personal information;
 - where such processing is unlawful and User do not want Dogezer to delete the User's data;
 - where Dogezer no longer requires such data, but User want us to retain the data for the establishment, exercise or defense of a legal claim;
 - where User has submitted an objection to processing based on Dogezer legitimate business interests, pending Dogezer response to such request.

Where Dogezer limits the processing of the User's personal information pursuant to the User request, Dogezer will inform User prior to re-engaging in such processing.

Sharing of Information

We will only share Information about the User in the following ways:

- with the User consent or at the User instruction;
- with the Dogezer current or future parent companies, affiliates, subsidiaries and with other companies under common control or ownership of the Dogezer internationally;
- with third parties or service providers that perform work for the Dogezer;

- certain information the User may choose to share may be displayed publicly, such as the User username and any content the User post when the User use interactive areas of the Website like the Dogezer online forums;
- in connection with a merger or sale of the Dogezer or Dogezer's business assets, or if the Dogezer does a financing or are involved in an acquisition or any other situation where Information may be disclosed or transferred as Dogezer or Dogezer's business assets;
- in response to a request for information if the Dogezer believes disclosure is in accordance with, or required by, any applicable law, regulation or legal process;
- if the Dogezer believes the User actions are inconsistent with the Dogezer user agreements or policies, or to protect the rights, property and safety of any Dogezer Party or others; and
- with third parties where aggregate Information is disclosed, which cannot be reasonably be used to identify the User.

We also seek to require our affiliates and service providers with whom we can share personal information to exercise reasonable efforts to maintain the confidentiality of Users' personal information.

Social Sharing Features

The Website may offer social sharing features, links to social media and other integrated tools. the User use of such features enables the sharing of information with the User contacts or the public, depending on the settings, with the entity that provides the social sharing feature or social media. Please visit the privacy policies of the entities that provide these features to obtain more information about the purpose and scope of data collection and the processing of such data by such entities.

Protection of Personal Information

The Dogezer takes reasonable steps to protect the security of the information communicated through the Website. Personal data the Dogezer collects is stored on protected servers. Access is restricted to a limited number of authorized persons who need the access in order to administer the Dogezer platform, the Website and the Services or ensure their proper functionality, especially with regard to technical support. However, no computer security system is entirely foolproof and the Internet is not a secure method of transmitting information. As a result, the Dogezer does not assume any responsibility for data the User submits to or receives from the Dogezer through the Internet or for any unauthorized access or use of that information and the Dogezer cannot and does not guarantee that information communicated by the User to the Dogezer or sent to the User by the Dogezer will be received or that it will not be altered before or after its transmission to the Dogezer. The User agrees not to hold the Dogezer and the Dogezer respective past, present and future employees, officers, directors, contractors, consultants, equity holders, suppliers, vendors, service providers, founders, parent companies, subsidiaries, affiliates, agents, representatives, predecessors, successors and assigns (collectively, the "Parties") liable for any loss or damage of any sort incurred as a result of any misappropriation, interception, modification, deletion, destruction or use of information provided through the Website.

Most web browsers are set to accept cookies as a default. The User may wish to opt out by turning off cookies (please refer to the help menu on the User browser); however, switching off cookies may restrict the User usage of the Website.

The User may also opt out of receiving promotional communications from the Dogezer at any time by writing to community@dogezer.com. If the User opts out, the Dogezer may still send to the User non-promotional communications, such as technical notices, support or administrative notifications or information about the User account, while account exists.

Hyperlinks and Third-Party Sites

The Website may contain links to other third party websites that may collect personal information about the User, including through cookies or other technologies. If the User links to another website, the User will leave the Website and this Privacy Policy will not apply to the User use of and activity on those other websites. The User should consult these other websites' privacy policies as the Dogezer has no control over them and are not responsible for any information that is submitted to or collected by these third parties.

Please note, however, that certain personal information may be exempt from such rights pursuant to applicable data protection laws. In addition, Dogezer will not respond to any request unless Dogezer is able to appropriately verify the requester's identity. Dogezer may charge User a reasonable fee for subsequent copies of data that you request.
